Openings for Contract Lecturer (Non-tenured) in the Interdepartmental English Language Program

1. Position: Contract Lecturer
2. Number of positions: Several
3. Qualifications and application requirements:
 - (1) Master's degree or higher, with experience teaching at a university or equivalent institution
 - (2) Specialization in English education or applied linguistics and experience with curriculum development and management is preferred.
 - (3) English ability sufficient for teaching in English (overseas experience preferred)
Japanese ability sufficient for handling university-related administrative matters
4. Affiliation: Teachers will belong to the Faculty of Law, but will be in charge of courses in the Interdepartmental English Language Program.
5. Duties:
 - (1) Teachers will be in charge of English courses that include Academic Reading Strategies, Academic Writing, Academic Listening Strategies, among others.
 - (2) Teachers will not be required to attend faculty meetings or perform committee work, but will be asked to attend meetings for the Interdepartmental English Language Program. Teachers will be involved in curriculum management and development, as well as student advising, and will be expected to be on campus four days a week.
6. Appointment: Beginning on April 1, 2019
7. Application process

- (4) Copy or offprint of one representative research publication (besides master's thesis), along with a summary of the publication in both English and Japanese
- (5) An essay in both English and Japanese on "Your views about College English Education." The essays should be approximately one page of A4 sized paper each, and should be based specifically on the applicant's achievements.
- (6) Copy of the applicant's final degree certificate / diploma
- (7) Copy of official certificate of English / Japanese proficiency (TOEIC, TOEFL, or Japanese-Language Proficiency test, etc.)

Short-listed candidates will be invited to an interview (including teaching demonstration) in both English and Japanese on October 13, 2018 (Saturday). Please note that transportation expenses will not be reimbursed.

Successful candidates will be notified directly. Applicants' personal information will be handled with the utmost care, and will not be used for any purpose other than selection.

10. Term of employment

3 years (renewable for an additional 3 years by mutual agreement for a maximum of 6 years)

Additional information

- (1) The Interdepartmental English Language Program is a coordinated program that stresses "English for General Academic Purposes" (EGAP). Students from the following faculties and departments take courses in the program: Faculty of Foreign Languages (Depts. of German and French), Faculty of

Economics (Depts. of Economics, Management Science, and Economics on Sustainability), and Faculty of Law (Depts. of Law, International Legal Studies, and Policy Studies). We seek to hire cooperative teachers who understand the goals and objectives of the program and participate actively to achieve them.

(2) “Contract Lecturer (Non-tenured)” refers to a position at Dokkyo University in which the term of employment and job duties are determined by an individual contract. The current opening is for a Contract Lecturer (Non-tenured) in charge of foreign language courses.

(3) The salary is based on a course load of nine classes and will be 350,000 yen per month. If additional classes become necessary, 21,700 yen per month will be paid for each additional class. Teachers will be provided with shared office space.

(4) Experience using CALL classrooms / ICT is preferred.
