

**One Limited-term Contract Teaching Position, Beginning September 2020**  
**English Course Section, Faculty of Global Communications, Doshisha University**

**Position:** Assistant Professor, Associate Professor or Professor, depending on qualifications

**Courses:** 1) General English courses for all undergraduate faculties in the university  
2) Major courses for the Faculty of Global Communications

**Contract Period:** From September 21, 2020 to September 20, 2025 (non-renewable)

**Qualifications and Application conditions (All of the following must be satisfied):**

- 1) First language is English
- 2) Holder of a Master's degree or above in the area of English language education (TESOL), applied linguistics, or a related academic field
- 3) At least three years' English teaching experience at the university level
- 4) Sufficient Japanese proficiency for general administrative tasks
- 5) Resident of the Kinki area of Japan during the contract period
- 6) At least two academic publications

**Responsibilities:**

- 1) Teaching load: A minimum of eight classes per week, spread over five days
- 2) Administrative responsibilities: Involvement in curriculum design and planning; materials development; counselling for course registration; participation in designated committees; entrance exam development, proctoring, and scoring; contributions to Doshisha's international exchange programs; PR activities for recruiting new students (including demonstration lessons at some university events)

**Application materials:**

- 1) Curriculum Vitae (履歴書, *rirekisho*), a list of academic publications (業績書, *gyosekisho*), and a list of previous work experience within Doshisha schools (職務経歴報告書, *shokumukeireki-houkokusho*) [if not applicable, please write "NA" or "なし" in the form]. - 2) One offprint/copy of each of two academic publications, with an English synopsis (up to 300 words) for each publication
- 3) Statement in English (about 1,000 words) or in Japanese (about 2,000 characters), explaining the reason for applying, including personal philosophy/comments regarding teaching methods
- 4) Names and contact information of two references (affiliation, phone number, e-mail address)
- 5) Copy of either Master's degree certificate or Doctorate certificate
- 6) Copy of TESOL diploma/certificate (if available)
- 7) Copy of document(s) certifying qualification at a certain level of the Japanese Language Proficiency Test (JLPT) or similar measurement of Japanese proficiency (if available)

**Deadline for application:** Application materials must arrive by 5 p.m., Friday, April 10, 2020, via registered mail (*kakitome*) or commercial parcel delivery (*takuhaibin*).
